Benekos) of *Crime Control, Politics & Policy,* 2nd Anderson), co-editor (with Peter J. Benekos) of *Controversies in Juvenile Justice and Delinquency,* 2nd edition, (LexisNexis/ Anderson); and co-editor (with Joycelyn M. Pollock) of *Women, Law & Social Control,* edition (Allyn and Bacon). She is the past-president of the Academy of Criminal Justice Sciences. In 2014, she received the Outstanding Teacher Award from the College of Health and Human Services at Indiana University of Pennsylvania. In 2012, she was presented with the Academy of Criminal Justice Sciences Minority Mentor Award. In 2004, she received the Academy's Fellow Award.
